It is mutually agreed that the following terms of agreement form an integral part of this Contract.

Booking Fee: A five hundred dollar deposit is required when the client signs and returns this Contract. Dates are reserved when Booking Fee is paid. The Booking Fee will be subtracted from the total cost of the Package.

Payment & Prices: No images will be given to the client until full payment has been paid to 8 Fotos. All Package costs are as stated at the time of booking & will remain once booking is confirmed.

Cancellation: In the event of cancellation, the deposit is non-refundable. Rescheduling is subject to a 25% surcharge.

Preview Images: All Previews & final photographs are posted online in our galleries. The gallery for your event will require a password which we will email to you for distribute to your party. All imaging services are processed by facilities around the country depending on the product you chose. All photographic images whether paper or Photo CD-Rom, are copyright protected. It is illegal to copy any images. High-resolution digital images are available for purchase.

Travel: Jobs outside a 25 miles radius could incur a travel charge. Overnight accommodation will be charged to the client if necessary.

Sole Rights: 8 Fotos Photographers will be the sole Professional Photographer at the Event.

Coverage: It is the Client's responsibility to make sure that members of the party are on time & available when requested for a photograph.

Requested Coverage: 8 Fotos will honor requested photographs.

Weather: 8 Fotos will make necessary changes due to weather disturbances.

Image Irregularities: Final images will match the original photographs, but may vary slightly depending on product ordered.

Act of God: 8 Fotos takes every care to performance of this Contract. But Contract is subject to Acts of God beyond our control; i.e. Fire or Police action.

Limitation of Liability: In the unlikely event that all of some of the photographs fail to materialize or there is total photographic failure due to reasons beyond 8 Fotos's control, the liability of 8 Fotos will be limited to the refund of all money paid. Neither party shall be liable for indirect or consequential losses. In any event, the limit of 8 Fotos's liability shall not exceed the Package Price.
